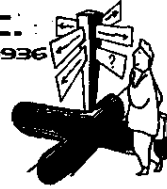



Last week, I received a "Notice of Administrative Dissolution or Revocation" in mail at my home address 6363 Gage Place, Miami Lakes 33014. Upon Inquiry, I was informed that there was in error in my reporting and the document was rejected for correction.
