THE UNDERSIGNED incorporator hereby forms a corporation under Chapter 617. (Not for Profit) of the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be:

JEWISHLY SPEAKING, INC.

ARTICLE II. PRINCIPAL OFFICE

The address of the principal office of this Corporation shall be 4020 Sheridan Street, Suite C, Hollywood, FL 33021, and the mailing address of the Corporation shall be the same.

ARTICLE III. PURPOSE

This Corporation's primary mission is to serve as an educational and spiritual source in our community dedicated to Jewish values and identity.

ARTICLE IV. MANNER OF ELECTION
