I have contacted your office at the number provided on the notice of administrative resolution form that I received this week, and was instructed to write this letter explaining why the corporation did not file its report and payment on time. Since we did not receive a prior report notice, I was instructed by your representative to make a check for \$61.25 to re-instate.

What I think happened is that any mail you sent to the corporate address which uses a PO Box 620102 Oviedo FL 32762-0102 did not get to us, because that PO Box was disabled for several months and most mail returned to sender. Post office explained that a billing error had occurred and the PO Box had been shut down. That address is good now and no further problems should occur.

This non-profit corp. is registered with the IRS and at this time has no financial resources, it is still being setup and methods for obtaining donations are now being defined.
