# **ARTICLES OF INCORPORATION**

OF

Suncoast Business Links, Inc.

A Corporation Not for Profit

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not-for-Profit Corporation Act, hereby adopts the following Articles of Incorporation:

## **ARTICLE I - NAME**

The name of the corporation shall be Suncoast Business Links, Inc.

## **ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be Post Office Box 243, Palm Harbor, Pinellas County, Florida 34682, or such other place as from time to time is designated.

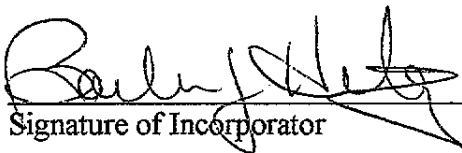

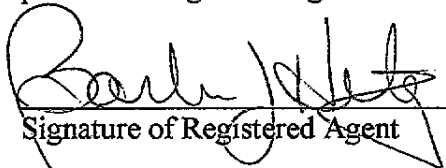
