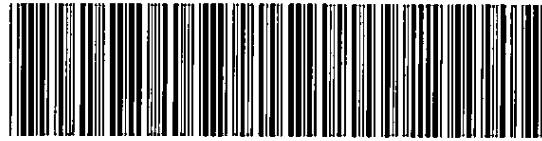

I.

CORPORATE NAME

The name of this corporation is SARASOTA CHRISTIAN SCHOOL, INC.

II.

CORPORATE NATURE

The general nature of the object of this corporation is to conduct for religious instruction and worship, schools and other institutions connected therewith of an educational, religious, charitable and benevolent character as defined under Section 501(c)(3) of the Internal Revenue Code of 1954, for the purpose of providing the rudiments of education required by the State of Florida and in the context suitable to the growth of Christian life and faith with Biblical interpretation regardless of race, color or national origin. All of the assets and earnings shall be used exclusively for the purposes hereunder set out, including the payment of expenses incidental thereto, and no pecuniary benefit shall ever be derived by any person from the development or operation of the corporation. Upon dissolution, none of the assets of the corporation remaining after the payments of costs and expenses of dissolution, shall be distributed to members, officers or directors, but shall be distributed to the participating Mennonite churches and other Mennonite organizations.

III.

PERM

This corporation shall have a perpetual existence.

IV.

MEMBERSHIP

The corporation shall have a membership distinct from the Board of Directors. The authorized number and qualifications of the members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting and other rights and privileges of members, shall be set forth in the By-Laws.

V.

REGISTERED AGENT AND OFFICE

The address of the corporation's registered office shall be 5415 Bahia Vista Street, Sarasota, Florida, and the name of its registered agent at said address shall be Paul Wenger.

VII.

MANAGEMENT OF CORPORATE AFFAIRS

(a) Board of Directors. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by its Board of Directors. The number of Directors of this corporation shall be not less than seven (7) nor more than fifteen (15), who shall be members in good standing of the participating Mennonite churches and who exemplify faith and loyalty to the Word of God, and who shall have an interest in the Christian education of children. The number of Directors may be changed by a by-law adopted by the members.

The Directors named herein as the first Board of Directors shall hold office until the first meeting of members at which time an election of Directors shall be held.

Directors elected at the first annual meeting, and at all times thereafter, shall serve for a term of three (3) years until the annual meeting of members following the election of Directors and until the qualification of the successors in office. Annual meetings shall be set by the By-Laws.






##### AMENDMENT OF ARTICLES






The general nature of the object of this corporation is to conduct for religious instruction and worship, schools and other institutions connected therewith of an educational, religious, charitable and benevolent character as defined under Section 501(c)(3) of the Internal Revenue Code of 1954, for the purpose of providing the rudiments of education required by the State of Florida and in the context suitable to the growth of Christian life and faith with Biblical interpretation. The schools shall admit students of any race, color, national or ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students at the schools. The schools shall not discriminate on the basis of race, color, national and ethnic origin in administration of its educational policies, admissions policies, scholarship and loan programs, and athletic and other school administered programs. Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law. All of the assets and earnings shall be used exclusively for the purposes hereunder set out, including the payment of expenses incidental thereto, and no pecuniary benefit shall ever be derived by any person from the development or operation of the corporation. Upon dissolution, none of the assets of the corporation remaining after the payments of costs and expenses of dissolution, shall be distributed to members, officers or directors, but shall be distributed


to the participating Nonprofit churches and other Nonprofit organizations as shall at the time qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 as amended (or the corresponding provisions of any future Internal Revenue law).
