ARTICLE ONE

Name

The complete legal name of the Corporation is NiteStalkers Paintball Club, Inc.

ARTICLE TWO

Duration

The term of existence of the Corporation is perpetual. The Corporation existence will commence on the filing of these articles by the Department of State.

ARTICLE THREE

Purpose

This corporation is being formed as a "Not For Profit" Corporation under Section 617.0301, Laws of 1999 of the State of Florida, for the purpose stated hereinafter.

The purpose for which the Corporation is organized is to support and promote Paintball competition and athletic education. The Corporation is organized in order to engage in any lawful purpose not for pecuniary profit.

Members

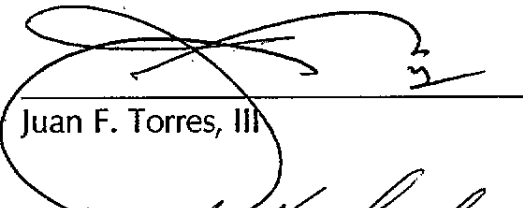
The Corporation shall have Members. Members of the Corporation will be required to meet the following qualifications:

Demonstrated willingness to aid in co-operation with paintball groups in obtaining competitive activities, and supplies to equip their teams and promotion teaching the sport of paintball.

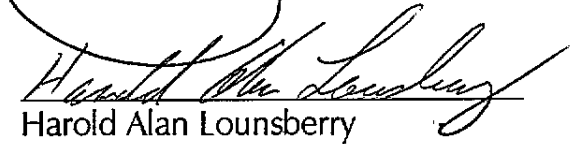

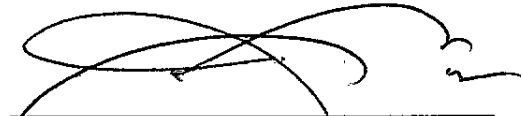

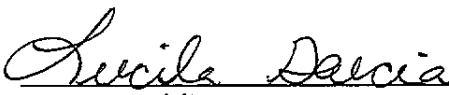
