MANAGEMENT OF CORPORATE AFFAIRS AND MANNER OF ELECTION OF DIRECTORS

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors, consisting of not less than three (3) persons. The number of Directors of the corporation shall be four (3), provided however, that such number may be changed by a By-Law duly adopted by the members.
