ARTICLES OF INCOPORATION OF

NORTH CENTRAL FLORIDA ASSOCIATION OF THE DEAF, INC.

The undersigned, acting as incorporator, for the purpose of forming a corporation under **The Florida Not for Profit Corporation Act**, hereby adopt(s) the following articles of incorporation:

ARTICLE 1

The name of the corporation shall be: North Central Florida Association of the Deaf, Inc.

ARTICLE 2

The principal place of business and mailing address of this corporation shall be: 802 NW Seminary Street, Micanopy, Florida 32609, Mailing address: Post Office Box 651, Archer, Florida 32618-0651

ARTICLE 3

This corporation is organized and shall be operating exclusively for charitable, social, service, and educational purposes as contemplated b and permitted by §170(c)(2) and §501(c)(3) of the Internal Revenue Code of 1954, as amended. It is a non-governmental, non-political, and customer controlled organization.

The specific purposes for which the corporation is organized is (are): To engage in and conduct charitable, social, service and educational activities, including planning, assisting with improvement of and evaluating services for persons with Deafness as further defined by the Bylaws of the North Central Florida Association of the Deaf, Inc. The corporation shall have the power to seek and receive grants, enter into contracts, receive donations that are legally give, buy, sell, rent, real and personal property, tangible or intangible.
