Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida not-for-profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE 1. NAME

The name of the corporation is SEA STREETS ACCESS ASSOCIATION, INC.

ARTICLE II. AMENDMENT

ARTICLE IV. PURPOSE of the Articles of Incorporation of SEA STREET ACCESS ASSOCIATION, INC., is amended to include the following language:

D. To perform all the duties and obligations of the Association as set forth in a certain Declaration of Covenants, Conditions and Restrictions (the Declaration) applicable to the aforescribed Easement which Declaration will be recorded in the Public Records of Palm Beach County, Florida.

E. To affix, levy and collect all charges and assessments pursuant to the terms of the Declaration and enforce payment thereof by any lawful means; and pay all expenses in connection therewith as well as all office and other expenses incident to the conduct of the business of the Association, including all licenses, taxes, or governmental charges levied or imposed on the property of the Association.

F. To have and exercise any and all powers, rights and privileges that a corporation organized under Chapter 617 of the Florida Statutes by law now or hereafter has or exercises.

ARTICLE III. DATE OF ADOPTION

This Amendment was adopted by the Board of Directors without voting Members on January 18, 2001.
