(N01000000234) EIN 65-1065285, a Florida not for profit corporation, certify that by unanimous vote of the board of directors (N01000000234) EIN 65-1065285, a Florida of locarporation were amended and restated as follows. There are no control of the community of the community of the community Housing Development Organization Inc. at a Special Meeting held April 28, 2002 the Articles of Incorporation were amended and restated as follows. There are no members:

- NAME: The name of the corporation is "Sunrise City Community Housing Development Organization Inc."
- PRINCIPAL OFFICE: The principal office and mailing address is: 1513 North 23rd Street, Fort Pierce, Florida 34950.
- PURPOSE: The corporation is a nonprofit public benefit corporation. It is not organized for the private gain of any person. It is organized and operated exclusively for charitable, religious, educational, and/or scientific purposes under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code ("Code") and may conduct any other activity permitted under Florida law and Code section 501(c)(3). In furtherance thereof, and not in limitation, within the City of Ft. Pierce, Florida, on a nonprofit basis, it shall provide decent housing that is affordable for low and moderate income families through the purchase and rehabilitation of homes or the construction of new homes, and their sale or rental. It shall provide continued social services for the benefit of the prospective homeowners to aid them in achieving and maintaining home ownership, and shall perform such activities that give reasonable promise that a stable environment shall be created in the neighborhood of such homes.
- NO MEMBERS: The corporation shall have no members. All rights, which would otherwise vest in the members, shall yest in the directors. Actions of the directors shall be by majority vote.
- 5. DIRECTORS & OFFICERS: The board of directors of the corporation shall consist of no less than seven persons. Directors and officers of the corporation shall be residents of Ft. Pierce, and shall be elected by majority vote of the directors at the annual meeting of directors, which shall be held on the first Tuesday of January. The directors and officers of the corporation are below enumerated:

PROHIBITED ACTIVITY: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers directors, or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the corporation shall be the carrying on propaganda, or otherwise attempting to influence legislation. The corporation shall not participate in, or intervene in (including the publishing distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activity not permitted to be carried on (a) by an organization exempt from federal income tax under Code section 501(c)(3) or (b) by an organization, contributions to which are deductible under Code section 170 (c)(2).
- 8. DISSOLUTION: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Code section 501 (c) (3), or shall be distributed to the federal, state or local government for a public purpose.
