**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: **Caribbean Technology Foundation Inc.**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 530 East Central Boulevard Suite 202, Orlando, Florida 32801. Located in the County of Orange.

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: The company provides very low-cost, or donated refurbished and recycled Information Technology supporting education programs. Company expenses are covered by receiving donations, and the sale of refurbished and recycled technology.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

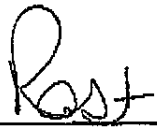

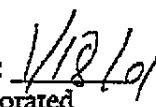
