

ARTICLES OF INCORPORATION

For

LATINO LEADERSHIP, INC.



The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of this Corporation is "Latino Leadership, Inc.".

ARTICLE II - Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be"

ARTICLE III - Statement of Corporate Purposes

The specific and primary purposes for which this Corporation is organized is/are:

The Organization will promote Educational Activities. Promote the history, culture and historical achievements of Hispanic/Americans to the overall American history/culture.

The Organization will do voter Registration and voter education.

The organization will attempt to do so by conducting conventions; seminars; scholarship funds and research into subjects which promote Hispanic/American culture and history.

The Organization will run an annual convention of members and non-members who will attend workshops and seminars ranging different topics concerning the life, history, future and culture of the Hispanic/American experience in the U.S.A. The organization will foster pride and unity among Hispanic groups through the above activities.

The Organization will provide funds for education and research to individuals or other organizations interested in studying the above topics.

The Organization will conduct activities which are exclusively charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954, as the same may be amended from time to time.

In furtherance of the foregoing purposes, the Corporation shall have all of the general powers enumerated in Sections of the Not-for-Profit Corporation Law together with the power to solicit grants and contributions for any corporate purposes.

Notwithstanding any other provision of these articles, the corporation is organized exclusively for one or more of the purposes as specified in Section 501 (c)(3) of the Internal Revenue Code of 1954, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Internal Revenue Code Section 501(c)(3) or corresponding provisions of any subsequent Federal tax Laws.

No part of the net earnings of the Corporation shall insure to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

No substantial part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Internal Revenue Code Section 501 (h) or participating in or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

In the event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to another organization exempt under Internal Revenue code Section 501(c)(3), or corresponding provisions of any subsequent Federal Tax Laws, or to the Federal government, or state of local government for a public purpose.

In any taxable year in which the corporation is a private foundation as described in Internal Revenue Code Section 4509 (a), the corporation shall distribute its income for said period at such time and manner as not to subject it to tax under Internal Revenue Code Section 4942, and the corporation shall not (A) engage in any act of self-dealing as defined in Internal Revenue Code Section 4941 (d), retain any excess business holdings as defined in Internal Revenue Code Section 4943(c), (B) make any investments in such manner as to subject the corporation to tax under Internal Revenue Code Section 4944, or © make any taxable expenditures as defined in Internal Revenue Code Section 4945(d), or corresponding provision of any subsequent Federal Tax Law.

ARTICLE IV - Manner of election of Directors
