ARTICLES OF INCORPORATION  
OF

INTERNATIONAL CHRISTIAN COMMUNITY DEVELOPMENT ORGANIZATION, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida under F.S. 617.

ARTICLE I - CORPORATE NAME

The name of this corporation is INTERNATIONAL CHRISTIAN COMMUNITY DEVELOPMENT ORGANIZATION, INC.

ARTICLE II - DURATION

The corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and the State of Florida under F.S. 617.

The corporation nor any of its directors, officers, employees, or representatives shall take any action or carry on any activity by or on behalf of the corporation which is not permitted to be taken or carried on by an organization exempt under section 501 c (3) of the Internal Revenue Code or by an organization contributions to which are deductible under Section 170 c (2) of the Internal Revenue Code, or the corresponding provisions of any future United States Internal Revenue law.

ARTICLE IV - MEMBERS

The corporation is to have one class of members, all members to possess such qualifications and rights as shall be designated by the Board of Elders from time to time and as set out in the By-Laws of the corporation. The members shall have the right to elect the initial Board of Elders and each succeeding Board of Elders at the annual meeting that occur on the dates set out oin the By-Laws of the corporation. Such election of the Elders shall be by a majority vote of all members, all as are set out in the By-Laws of the corporation.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the Initial Registered Agent office and name of the Initial Registered Agent at that office is: Yvan Pierre, 1538 Immokalee Street, Intercession City, Florida 33848.

The principal office of the corporation is: 1538 Immokalee Street, Intercession City, Florida 33848.

ARTICLE VI- TERMINATION


On the dissolution of this corporation the Board of Directors shall dispose of all the assets of this corporation exclusively for the purpose of this corporation in a manner or to the organization or organizations that are organized and operated exclusively for charitable, educational, religious or scientific purposes and that shall at the time qualify as exempt organizations under 501 c (3) of the Internal Revenue Code , or the corresponding provision of any future United States Internal Revenue law.

ARTICLE VI - INITIAL BOARD OF DIRECTORS (BOARD OF ELDERS)


