# Christian Trans-denominational Spiritual Growth & Enlightenment Prayer Group

#### Article I - Name

The name of the assembly shall be the Christian Trans-denominational Spiritual Growth and Enlightenment Prayer Group, commonly known as the Spiritual Growth & Enlightenment (S.G.E) Prayer Group.

## Article II - Purpose and Objectives

The purpose of this group shall be to provide the opportunity for prayer, bible study, fellowship, singing, exhortation, and sharing. Other purposes are as follows:

- 1. To advance spiritual growth, enlightenment, moral and personal purity.
- 2. To aid in the spread of the Gospel of Jesus Christ.
- 3. To be a praying unit for all of the University family.
- 4. To help guide the lives of youth and adults.
- 5. To provide a place for the troubled and confused, the drug addicts, and the mislead to find relief and direction.
- 6. To provide tutoring and mentors for all students.
- 7. To provide guidance for students in making career choices.

# Article III - Eligibility for Membership

Membership is open to all students enrolled full or part-time who desire to be in fellowship with the group. In addition, membership may include but not limited to just students; however, faculty and support staff are encourage to join.

Membership is granted at the request of the individual upon signing a written request suggesting the guidelines stated by the board.

There are no barriers. (Race, sex, age, national origin, or religious affiliation).

This is not an academic organization; therefore, no specific grade point average is required to become a member.

## Article IV - Officers

The elected officers of the Christian Trans-denominational Spiritual Growth and Enlightenment (C.T.S.G.& E.) Prayer Group shall consist of a director, assistant director, and an administrative assistant.

#### Article V - Officers and Duties

The director or his/her designee is to preside at all meetings and represent the group before the faculty, staff, and student body (college and university).

The assistant director will act as parliamentarian and sergeant-at-arms at formal meetings, and act in the absence of the director. The assistant director may from time to time be assigned special tasks by the director.

The administrative assistant shall maintain the records of the group, handle all correspondence, and disseminate information to all significant others. It is also the responsibility of the administrative assistant to notify members of changes in any scheduled meeting or event.

Presently, the director will be in charge of all finances including the group's funds, making disbursements, and compiling monthly financial statements until the board reconvenes and reappoints someone as treasurer.

Article VI - Election of Officers

The officers shall be selected every 3 to 5 years by the C.T.S.G.& E. Prayer Group board.

New officers shall hold office for a period of three years. Should an elected officer becomes unable to complete the term, the director shall appoint a substitute.

Article VII - Finances
Annual dues will not be required.

Funds may be assessed upon the approval of a majority of the membership for specific reasons.

Expenditures shall be made by a majority vote of the present body members for activities which support the purposes and objectives of the group. Reports on the financial condition of the group shall be made at the meetings by the treasurer. If the members are unable to meet, the expenditures' report shall be made at the discretion of the executive committee.

Article VIII - Appointment of Committees

Committees shall be appointed at the discretion of the board as needed.

Article IX - Declaration

The Chrisitian Trans-denominational Spiritual Growth and Enlightenment Prayer Group is an organization that has been on going since 1989 on the campus of Florida State University with a local minister and director, Teri Calhoun. The CTSG & E is a trans-denominational, multi-racial, loving, caring, praying, and giving Ministry designed to train the young and the

old in the ways of Jesus Christ and enlighten people's understanding in the area of new horizons, new heights, and new ways of expressing themselves.

Article X - Adoption of the Constitution of the Christian Trans-denominational Spiritual Growth and Enlightenment Prayer Group.

This Constitution of the Christian Trans-denominational Spiritual Growth and Enlightenment Prayer Group, as approved by 2/3 vote of the membership present, is effective as January 10, 2001.
