Constitution
Of
Christian Trans-denominational S.G.E. Prayer Ministry, Inc.

Article I - Name

The name of the assembly shall be the Christian Trans-denominational Spiritual Growth and Enlightenment Prayer Ministry, Inc., commonly known as the Spiritual Growth & Enlightenment (S.G.E) Prayer Ministry.

Article II - Principal Office

1432 Golden Park Court Tallahassee, FL 32303

Article III - Purpose and Objectives

Purpose: The corporation is organized exclusively for charitable, educational, religious, or scientific purposes within the meaning of Section 501©(3) of the Internal Revenue Code.

Dissolution Clause: Upon dissolution of the corporation, the Board of Trustees shall, after paying or making provisions for the payment of all liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organization under Section 501©(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law), as the Board of Trustees shall determine. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes

The objective of this group shall be to provide the opportunity for prayer, bible study, fellowship, singing, exhortation, and sharing. Other objectives are as follows:

1. To advance spiritual growth, enlightenment, moral and personal purity.
2. To aid in the spread of the Gospel of Jesus Christ.
3. To be a praying unit for all of the University family.
4. To help guide the lives of youth and adults.
5. To provide a place for the troubled and confused, the drug addicts, and the mislead to find relief and direction.
6. To provide tutoring and mentors for all students.
7. To provide guidance for students in making career choices.

Article IV - Officers & Election of Officers

The elected officers of the Christian Trans-denominational Spiritual Growth and Enlightenment (C.T.S.G. & E.) Prayer Ministry, Inc. shall consist of three directors, assistant director, and an administrative assistant.

The officers shall be selected every 3 to 5 years by the C.T.S.G. & E. Prayer Group board.

New officers shall hold office for a period of three years. Should an elected officer become unable to complete the term; the director shall appoint a substitute.

Eligibility criteria for selection:

- The person must present a Vita illustrating leadership qualification and three letters of reference displaying good moral character of the applicant.
- The person must have at least a year of leadership training indicating decision-making qualities.
- The person must demonstrate practical application of following the practices and teachings of Jesus.
- The person must be a member of the C.T.S.G.E. Prayer Ministry for at least two years.

Article V - Officers and Duties

The director or his/her designee is to preside at all meetings and represent the group before the faculty, staff, and student body (college and university).

The assistant director will act as parliamentarian and sergeant-at-arms at formal meetings, and act in the absence of the director. The director may from time to time assign the assistant director special tasks.

The administrative assistant shall maintain the records of the group, handle all correspondence, and disseminate information to all significant others. It is also the responsibility of the administrative assistant to notify members of changes in any scheduled meeting or event.

Presently, the director will be in charge of all finances including the group's funds, making disbursements, and compiling monthly financial statements until the board reconvenes and reappoints someone as treasurer.

Article VI - Eligibility for Membership

Membership is open to all students enrolled full or part-time and significant others who desire to be in fellowship with the ministry. In addition, membership may include but not limited to just students; however, faculty, support staff, and significant others are encourage in joining.

Membership is granted at the request of the individual upon signing a written request suggesting the guidelines stated by the board.

There are no barriers. (Race, sex, age, national origin, or religious affiliation).

This is not an academic organization; therefore, no specific grade point average is required to become a member.

Article VII - Finances

Annual dues will not be required.

Funds may be assessed upon the approval of a majority of the membership for specific reasons.

Expenditures shall be made by a majority vote of the present body members for activities, which support the purposes, and objectives of the group. The treasurer shall make reports on the financial condition of the group at the meetings. If the members are unable to meet, the expenditures' report shall be made at the discretion of the executive committee.

Article VIII - Appointment of Committees

Committees shall be appointed at the discretion of the board as needed.

Article IX - Declaration

The Christian Trans-denominational Spiritual Growth and Enlightenment Prayer Ministry is an organization that has been on going since 1989 on the campus of Florida State University with a local minister, pastor and director, Teresita Calhoun. The CTSG & E Prayer Ministry, Inc. is a trans-denominational, multi-racial, loving, caring, praying, and giving Ministry designed to train the young and the old in the ways of Jesus Christ and enlighten a person's understanding in the area of new horizons, new heights, and new ways of expressing themselves.

Article X - Adoption of the Constitution of the Christian Trans-denominational Spiritual Growth and Enlightenment Prayer Ministry, Inc.

This Constitution of the Christian Trans-denominational Spiritual Growth and Enlightenment Prayer Group, as approved by 2/3 vote of the membership present, is effective as January 15, 2002.
