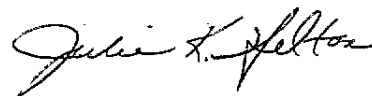

ARTICLE I NAME

The name of the not for profit corporation shall be: Citizens for Health Freedom, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the not for profit corporation is organized is to support patients' rights to have access to responsible medical alternatives from licensed health care practitioners, to promote and encourage the availability of innovative health care in the U. S. and to undertake all other lawful actions necessary to accomplish this purpose and any other lawful purpose not for pecuniary profit, including but not limited to charitable, benevolent, eleemosynary, educational, historical, civic, patriotic, political, religious, social, fraternal, literary, cultural, athletic, scientific, agricultural, horticultural, animal husbandry, and professional, commercial, industrial or trade association purposes.

ARTICLE IV MANNER OF ELECTION

The Board of Directors shall consist of no more than nine (9) and no less than three (3) members. All directors shall be elected as provided in the bylaws.
