ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be **Truth for Troubled Youth Ministries, Inc.**

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSES

The specific purposes for which the corporation is organized are:

1. To provide religious services to troubled youth located in juvenile residential corrective or rehabilitative programs at no charge to the facility or juvenile. Services include: free religious literature, conducting weekly services, spiritual counseling, and voluntary follow-up after the youth is released.
2. To provide services to local churches by ministering in youth revivals, youth camps, or through juvenile delinquent ministry or camp meetings.




