A Corporation Not For Profit

We, the undersigned members of **HOLY PEOPLE / PUEBLO SANTO / BOMBILLOS DE CRISTO, INC.** of West Palm Beach, Florida, hereby form ourselves and our successors into a corporation not for profit under the corporate name of **HOLY PEOPLE / PUEBLO SANTO / BOMBILLOS DE CRISTO, INC.**, and hereby adopt the following articles of incorporation:

ARTICLE I. - NAME

The name of this Corporation shall be **HOLY PEOPLE / PUEBLO SANTO / BOMBILLOS DE CRISTO, INC.**, with headquarters located in West Palm Beach, Palm Beach County, Florida, and doing outreach in the United States of America, the Dominican Republic, the Caribbean, and the World.

ARTICLE II. - PURPOSE

The general nature and object of this corporation is to buy, purchase, own, acquire, by gift, devise, purchase or otherwise, real and personal property, and to build, erect, construct, provide for, maintain and equip suitable buildings, churches, houses, etc. for the benefit, use and occupation of said **HOLY PEOPLE / PUEBLO SANTO / BOMBILLOS DE CRISTO, INC.**, its members and congregation, in maintaining and fostering public worship, and the preaching and teaching of the Word of God and the Gospel of Jesus Christ, and for all other meetings and purposes of the said **HOLY PEOPLE / PUEBLO SANTO / BOMBILLOS DE CRISTO, INC.**, its members and congregation. To build, construct, erect, maintain and equip schools, mission stations and mission churches, pastors' homes and such other houses or equipment as the church may desire for carrying on its work.

To receive, administer, disburse and invest gifts, devises and bequests by or from any persons or corporations.

To issue bonds, notes, debentures and evidences of indebtedness, and to secure the same by mortgage, deed of trust or otherwise.

This corporation is organized primarily for the purpose of holding the title to such property or properties as the said, **HOLY PEOPLE / PUEBLO SANTO / BOMBILLOS DE CRISTO, INC.** This organization shall from time to time, purchase or acquire, and it shall have power, from time to time, to make such contracts and to do such things as shall be authorized and directed by the **OFFICERS** and **INCORPORATORS** of said **HOLY PEOPLE / PUEBLO SANTO / BOMBILLOS DE CRISTO, INC.**

ARTICLE VII. - INITIAL DIRECTORS AND ADDRESSES

ARTICLE VIII. - INITIAL REGISTERED OFFICE AND AGENT

The street address and city of the initial registered office of the corporation is 1106 11th Way West Palm Beach, FL 33407.

ARTICLE IX. - BY-LAWS

The By-Laws of this corporation shall be made, altered or amended by the corporation at any regular or special meeting duly and legally called, but any alterations or amendments of said By-Laws shall only be made by full agreement among the INCORPORATORS.

ARTICLE X. - CAPITAL STOCK

This corporation is organized on a non-stock basis.

ARTICLE XI. - COMMENCEMENT OF CORPORATE EXISTENCE

In accordance with Section 607.167, Florida Statutes, the date when corporate existence shall commence is the date of: *Filing with the Dept. OF State.*

ARTICLE III. - MEMBERSHIP

The membership of this corporation shall consist of the members of the HOLY PEOPLE / PUEBLO SANTO / BOMBILLOS DE CRISTO, INC. in good and regular standing in said Church, to be elected by the said Church at its regular business meeting in July of each year, or as soon thereafter as convenient, to serve for the period of One (1) year and until their successors are elected and qualified. If any member ceases to be a member of said HOLY PEOPLE / PUEBLO SANTO / BOMBILLOS DE CRISTO, INC, in good and regular standing, he shall cease to be a member of this corporation, and the vacancy may be filled by the members of said Church at any regular business meeting of said Church, or at any meeting called for that purpose.

ARTICLE IV. - DURATION

The term for which this corporation shall exist shall be perpetual.

ARTICLE XII.

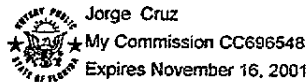
