We (I), the undersigned resident(s) of the State of Florida, do hereby associate ourselves together for the purposes of forming a corporation under the statutes of the State of Florida.

ARTICLE ONE  
NAME

The name of the corporation shall be BEIT MELEKH YISRAEL, INC., and the initial principal office and mailing address shall be 17020 SW 93 Avenue Miami, Florida 33157.

ARTICLE TWO

The period of duration of this nonprofit corporation shall be perpetual.

ARTICLE THREE  
PURPOSE

The general nature of the objectives and purposes of the Corporation shall be:

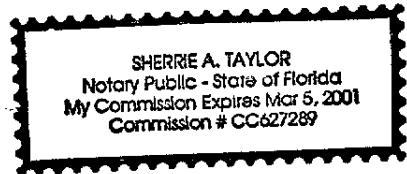


