**ARTICLES OF INCORPORATION  
OF  
FRIENDS OF STERLING OAKS, INC.**

The undersigned, for the purpose of forming a nonprofit corporation under Chapter 617 of the laws of the State of Florida, does hereby make and adopt the following Articles of Incorporation:

**ARTICLE I  
Name and Address**

The name of the Corporation is Friends of Sterling Oaks, Inc.

The principal address and the mailing address of the Corporation is 4501 Tamiami Trail N., Suite 300, Naples, Florida 34103.

**ARTICLE II  
Not For Profit**

This Corporation is a corporation not for profit under the laws of the State of Florida.

**ARTICLE III  
Duration**

The duration of the Corporation shall be perpetual.

**ARTICLE IV  
Purposes**

The purposes and objects of the Corporation are to prepare for the turnover of Sterling Oaks Community Association and Club, Inc., a Florida not for profit corporation, that manages and operates the Sterling Oaks Community, a residential community located in Collier County, Florida, and such other purposes as are authorized under Chapter 617 of the Florida Statutes. The Corporation is organized and operated solely for administrative purposes. It is not intended that the Corporation show any net earnings, but no part of any net earnings that do occur shall inure to the benefit of any private member.

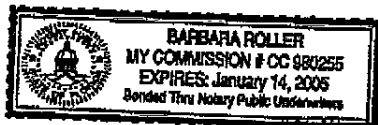
