## ARTICLES OF INCORPORATION

*The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:*

### ARTICLE I

#### Name

### ARTICLE III

#### Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

- 1). To act as a non profit charitable organization for the purpose of helping those in need within our local communities regardless of race, creed or religious affiliation.
- 2). To act as a non profit charitable nissionary outreach for the purpose of helping the poor and suffering of Haiti and other Third World nations.

### ARTICLE IV

#### Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

As stated in the By-Laws: The Directors of these Articles of Incorporation shall be three of the original members of the corporation. Additional members may be appointed by the original members as needed for terms of one year. A term may be dissolved by full agreement of the original members.

**ARTICLE V**

**Limitation of corporate powers**

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

- V.1) The Corporation shall have all corporate powers permitted under (state) law and shall be specifically precluded from engaging in any prohibited activities as defined in Florida statutes.
- V.2) The period of Duration of the Corporation shall have perpetual existence. In the event of dissolution of this Corporation, no part of the Corporation's assets shall be inure to the benefit of any member but shall instead be distributed to charitable organizations selected by the final Board of Directors of the Corporation which organization must qualify as a charitable organization under Section 170 and 501(c)(3) of the US IRS code.

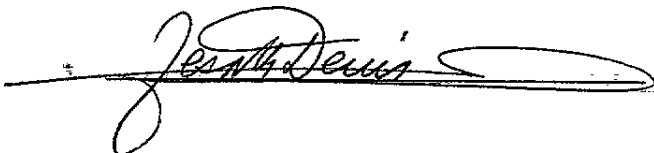
