Articles of Incorporation OF THE

FRIENDS OF THE BREAST-CANCER@MUN.CA LISTSERV,

Article I: The name of the corporation is "Friends of the Breast-Cancer@mun.ca Listserv, Inc."

Article II: The principal place of business and mailing address of the corporation is 1975 East Sunrise Boulevard, Suite 625-A, Fort Lauderdale, Florida 33304.

Article III: The specific purpose or purposes for which the corporation is organized:

The primary purpose of Friends of the Breast-Cancer@mun.ca Listserv, Inc. (hereinafter "FBCL"), includes, but is not limited to, the support of the Breast-Cancer@mun.ca Listserv (hereinafter the "Listserv") and its members in all appropriate ways, particularly raising money for scholarships to assist members of the Listserv who could not otherwise afford to attend Listserv gatherings.
