Incorporation stated below files with the State Department of Florida these Articles of Incorporation with the purpose of forming a Non Profit Foundation under the laws of the State Of Florida.

ARTICLE I

Name

The name of this Foundation shall be known as Centro Cristiano Casa de Oracion y Adoracion Inc.. (Cross Reference Name: House of Prayer & Worship Christian Center Inc)

ARTICLE II

Principal Office / Terms of Existence

The physical address shall be 1920 E. Central Florida Pkwy Orlando, Fl 32837, but may establish openly this Church in different states throughout the United States by the Centro Cristiano Casa de Oracion y Adoracion Inc. main office in the State of Florida. This Foundation will have a Perpetual Existence.

ARTICLE III

Purpose(s)

The purposes for which the Centro Cristiano Casa de Oracion y Adoracion Inc. is organizing are the following:

- *Creating Church with center of Prayer and Worship*

This Church will create different commissions that will have programs for families or single individuals, and they are the following:

Commission to work to help people :

Drug Rehabilitation

Others:

**Biblical Studies for children and adults.
School**

Commission to work with the community:

**Support Program(child abuse, alcoholic, and conseling)
Economic and l or Financial help on various family bills.
Interest orientation, Health, Food and Clothing**

**Commission to prepare different activities for collecting funds for the
construction of the:**

**Rehabilitation Center to help and assist Hispanics or
Americans in general(drug addicts, homeless, sexually abused
children).**

Construction of the School.

**This Church will have contact with different Government Agencies to receive referral
cases.**

We shall be adding more help programs not mentioned at this moment in the Article.

ARTICLE IV

Board of Directors

**The names and addresses of the incorporators shall be the initial directors of the
Church), who are subject to these articles of incorporation and the laws of the State of
Florida. This initial Board will work to complete the Statutes that shall govern the
destination of the Church including the regulations. The Board of Directors has
already been appointed and is composed of the following positions:**

**Our Church shall not and will not discriminate by race, color, sex, politics, religion or
social condition. The proposed form of selection of the new Board of Directors is as
follows: The Church will work with different Commissions- some shall be permanent
incumbents (Reverend Mildred Cortes, she can leave the position voluntarily) and**

others will be transitional, named by the Director in accordance of the needs. Each commission will have its Director and team of work. The Director will be responsible for his or her commission. These Directors are the ones that may aspire for the election to the Board of Directors; or the incumbent may be re-elected to his/her same position or a new one. The incumbent's term of eligibility is 5(five) years. For this period, all the work by these incumbents is voluntary. After the initial 5-year period, the Board of Directors will determine whether to pay some salary for the work. The permanent incumbent Director, once fulfilled his or her term, will be given a position of advisor. The Board of Director maybe replaced if they do not conduct his(her) job responsibly. If necessary the Board of Directors has the right and faculty to replace any person of the Church for disciplinary actions. The punishment or suspension may be canceled until the person can demonstrate he(he) can manage jobs duties of the positions. This term will be discussed as we work with our regulations.

ARTICLE V

Initial Registration of the Official Agent

The registered initial Agent for this documentation shall be Reverend Mildred Cortes. The address of the initial Registered Office for the Church is 171 Floral Dr. Kissimmee, Fl. 34743. This address is not permanent.

All of the directors and incorporators sign a written statement manifesting their intention that certain amendments of these Articles of Incorporation are made.

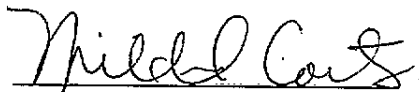
