ARTICLES OF INCORPORATION

**ARTICLE I
Name**

The name of the corporation shall be: **Thy Kingdom Outreach, Inc.**

**ARTICLE II
Principal place of business and mailing address**

The principal place of business and mailing address of this corporation shall be: 6774 Magnolia Homes Road, Orlando, Florida 32810.

**ARTICLE III
Formation and Purpose(s)**

The organization is being formed for charitable purposes, as one of the exempt purposes mentioned in Code Sec. 501(c)(3). The organization is organized and operated exclusively for a church, religious and related outreach ministries.

**ARTICLE IV
Members**

Insofar as permitted by the Internal Revenue Code, the Corporation shall have members. The initial members shall be: Joe L. Warren and Parcella Warren. Any vacancy created in the membership may be filled by a majority vote of the remaining members.

**ARTICLE V
Manner of Election of Directors**

The manner in which the directors are elected or appointed is as follows: The directors shall be elected annually at a meeting of the members. The directors shall be chosen by a plurality of the votes cast at such election.

Corporate Powers**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be

the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

**ARTICLE VIII

**ARTICLE X
Dissolution**

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
