ARTICLES OF INCORPORATION
OF
COUDERT INSTITUTE, VILLA DEI FIORI, INC.

THE UNDERSIGNED subscriber to these Articles of Incorporation, a Florida not-for-profit corporation, hereby forms a corporation under the Laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is COUDERT INSTITUTE, VILLA DEI FIORI, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal office of the corporation and the mailing address shall be 163 Seminole Avenue, Palm Beach, Florida 33480. The location of the principal office may be changed from time to time by the Directors of the corporation.

ARTICLE III. PURPOSE

This corporation is a non-profit corporation organized for educational purposes pursuant to the Florida Not for Profit Corporation Act as set forth in Chapter 617, Florida Statutes, and not for the private benefit of any person.

The specific and primary purposes of the corporation are the following:

(a) to encourage purposeful dialogue about subjects that matter with people who can make a difference.

(b) to generally do and perform all and every act, matter and thing that nonprofit corporations are by law authorized to do and perform.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954, and all subsequent amendments; or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 and all subsequent amendments.

ARTICLE IV. MANNER OF ELECTION

The powers of the corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors. The directors shall be elected or appointed in the manner and for the terms provided in the By-Laws.

ARTICLE V. INITIAL DIRECTORS/OFFICERS

This corporation shall have two (2) directors initially. The third director will be named in the manner and terms as provided in the By-Laws. The number of directors may

be increased or decreased by the By-Laws and shall never be less than three (3). The names and addresses of the initial directors of this corporation are:


