

The undersigned, acting as sole incorporator, does hereby desire to form a non-profit corporation pursuant to the Florida Not for Profit Corporation Act and does hereby adopt the following Articles of Incorporation:

Article I-Name of Corporation

The name of the corporation shall be TEE-LO GOLF, INC.

Article II-Term of Existence

The corporation shall commence its corporate existence upon the execution of these Articles of Incorporation and shall exist perpetually.

Article III-General Purposes

The general purposes for which the corporation is organized shall be to manufacture, construct, purchase, or otherwise acquire, dispose of, and to invest in, trade in, and deal in and with products, goods, wares, merchandise, real and personal property and services of every kind, class, and description. It is intended that the corporation is organized for and may conduct and transact any an all lawful business authorized and not prohibited by the Florida Not for Profit Corporation Act, as the same may be, from time to time, amended.

Article IV-Initial Registered Office and Agent


Article VII-Principle Office; Mailing Address
