ARTICLE I

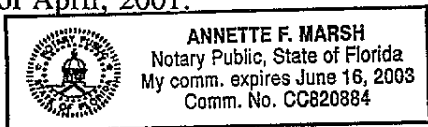

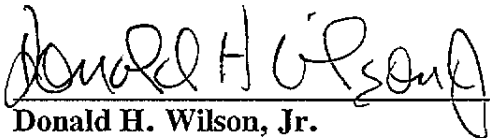

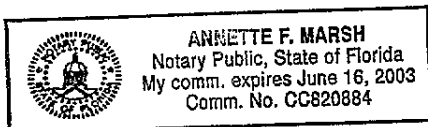
