The undersigned incorporator to these Articles of Incorporation hereby form a corporation under the laws of the State of Florida as follows:

# ARTICLE I

# Name and Address

The name of this Corporation: Deltona Hispanic Parade, Inc.

# ARTICLE II

# Term of Existence

This Corporation shall have perpetual existence, commencing upon filing of these articles of incorporation with the Florida Secretary of State.

# ARTICLE III

# <u>Purpose</u>

The specific purposes for which the corporation is organized are exclusively for educational and charitable purposes.

Specifically, this organization is organized to:

a. provide a forum for communicating ideas, resolving problems, and increasing the cultural awareness to the community;

- b. educate Deltona Hispanic Parade, Inc. members and the public concerning the advantages of promoting cultural awareness;
- c. encourage the participation of schools, civic groups, and individuals in promoting the values of diversity in and around the surrounding areas.

### ARTICLE IV

# Powers

The corporate powers of this corporation are as prescribed in section 617.0302, Florida Statutes, subject to the following limitations:

No part of the net earnings of the corporation shall inure to the benefit of any private individual. No substantial part of its' activities will be carrying out propaganda or otherwise attempting to influence legislation. The corporation will not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Upon dissolution, all assets of the corporation will be distributed to organizations exempt under Internal Revenue Code section 501 (c) (3). Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or

exercise any powers that are not in furtherance of the purposes of this corporation.

### ARTICLE V

# Initial Registered Office and Agent

The street address of the initial registered office of this Corporation is 1551 Ardenwood Lane, Deltona, Florida 32738 and the name of its initial registered agent at such address is Alba I. Perez.

### ARTICLE VI

# Board of Directors

This Corporation shall have no fewer than three directors as required by section 617.0803, Florida Statutes. The number of directors may be either increased or diminished from time to time as provided in the Corporation's Bylaws, but shall never be less than three (3).

# Manner of election of directors:

The manners in which the directors are elected are as required in section 617.0202(d), Florida Statutes.

Methods of election are as set forth in the bylaws of this corporation, which states that elections shall be held at the regular monthly meeting in January every two years. In the event of lack of a quorum, elections shall be held at the next regular

meeting at which a quorum is present and all officers shall serve until such elections.
