AMENDED ARTICLES OF INCORPORATION OF TAMPA BAY BLACK HERITAGE FESTIVAL, INC.

Please amend the Articles of Incorporation for the Tampa Bay Black Heritage Festival, Inc. Document Number N01000004528 that are currently on file with the Division of Corporations with Articles listed below.

Please replace Article II- Principal Office that is currently on file with the Department of State with the following language:

ARTICLE II Prinicipal Office

The principal place of business of The Tampa Bay Black Heritage Festival, Inc. shall be Tampa, Hillsborough County, Florida. The mailing address of the corporation shall be:

Tampa, Florida 33687-6682

The business of the corporation may be conducted in all counties of the State of Florida and in all States of the United States, and in all other points as the Board of Directors shall determine necessary to carry out its purpose.

Please replace Article III- Purpose with the following language:

ARTICLE III Purpose

This corporation is organized for cultural, charitable and educational purposes, more specifically, the purposes of the corporation shall be

- (1) to educationally increase and enrich the level of knowledge and understanding of African American history and culture both cross-culturally and among African Americans,
- (2) to increase diversity awareness and cultural sensitivity in the Tampa Bay area through culturally specific programs, including but not limited to seminars, entertainment, and activities.
- (3) to heighten cultural pride and self-respect among African American youth through participation in culturally enriching opportunities designed to improve academic performance and enhance social skills,
- (4) to provide an opportunity to experience African American culture through African/African-inspired artifacts and goods, and
- (5) to engage in any and all activities and pursuits, and any and all other lawful purposes, activities and pursuits, which are substantially similar to the foregoing and which are or may hereafter be authorized by Section 501(c)(3) of the IRS Code including the

solicitations of funds to support foregoing stated purposes to the extent lawfully allowed. Please replace Article IV- Manner of Election with the following language:

ARTICLE IV Membership and Board of Directors

The corporation shall have no members. The management and regulation of the internal affairs of the corporation shall be vested in a Board of Directors which shall be set forth in the corporation's Bylaws. The number of directors, but shall not be less than three. No Director shall have any right, title, or interest in or to any property of the corporation.

Members of the first Board of Directors shall serve until the first annual meeting, at which time their successors are duly elected and qualified, or removed as provided in the Bylaws. Please amend Article VI- Registered Agent and Street Address to the following:

Please add an Article VIII with the following language listed below:

ARTICLE VIII Distribution / Dissolution

Section One Distribution

Said organization is organized exclusively for charitable, cultural, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earning of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an

organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code. **Section Two** Dissolution

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
