Comes now all the officers and directors of the corporation known as "NEW BEGINNING FAMILY FELLOWSHIP, INC." and do hereby amend the articles of said Corporation by adding the following two (2) articles to wit:

**FIRST: Amendments being added:**

**ARTICLE IX** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes.

**ARTICLE X** No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statement) any political campaign on behalf of, or in opposition to, any candidate for public office.
