Pursuant to the provisions of sections 617.0202, Florida Statutes, the Undersigned Corporation, organized under the laws of the State of Florida, submits the following statement in designating the registered office/registered agent, in the State of Florida.

1. **NAME AND PRINCIPAL OFFICE:**

2. **PURPOSE**

The corporation shall serve to provide home purchase assistance in the form of grants to low income or other homebuyers who may be able to qualify for mortgage loans. The grants made shall be made in a manner consistent with the requirements of the laws of the State of Florida and of the Internal Revenue Service and shall not be based on any formula or criteria based on race, creed, color, disability or sexual orientation

3. **MANNER OF ELECTION:**

The officers shall be elected by a Board of Directors consisting of five persons whom shall be nominated to the Board of Directors from local government or community based organizations. The Directors shall serve terms of one, two, and three years and shall be staggered after the initial organizational meeting. The officers shall serve one-year terms unless reappointed by the Board of Directors.

4. **INITIAL DIRECTORS:**
