**ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I NAME**

The name of the corporation shall be:

**ARTICLE IV MANNER OF ELECTION**

Officers shall be elected at the annual In-Service Conference and shall assume their duties of office on July 1 following their election.

Voting for officers shall be done at the annual In-Service Conference meeting. The candidate receiving the majority of the votes cast at the meeting shall be declared elected in each case.
