In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

ARTICLE III PURPOSE

The M.C. Gavins Grace and Mercy Ministries is a religious "not for profit" Organization which exists to go into all the world to preach the gospel of the Kingdom as a witness to all nations as Jesus Christ commanded. We also engages to maintain family devotion; to religiously educate our children; To seek salvation of our kindred; to be just and righteous in all our dealings; and to Abstain from all filthiness of the body, mind, and spirit.
