

# ARTICLES OF INCORPORATION OF 4th FLORIDA COMPANY K, INC.



## A CORPORATION NOT FOR PROFIT

### UNDER CHAPTER 617 OF THE FLORIDA STATUTES

The undersigned, for the purpose fo forming a corporation under Chapter 617 of the Florida Statutes, now hereby certify:

- 1. NAME: The name of the corporation is 4th FLORIDA COMPANY K, INC. 3663 Bee Ridge Road, Sarasota, Florida 34233
- 2. Purpose: The purpose for which the corporation is to be formed is scientific, educational and charitable purpose within the meaning of Section 501(c)(6) of the Internal Revenue Code of 1954, and in that connection, to preserve the memory of certian historic events, to take and hold by bequest, devise, gift, grant, purchase, lease or otherwise any property, real, personal, tangible or intangible, or any undivided interest therein, without limitation as to amount or value; to sell, convey, or otherwise dispose of any such property and to invest, or deal with or deal with the principle or the income thereof in such manner as, in judgement of the directors, will best promote the purpose of the corporation without limitation, except such limitations, if any, as mey be contained in the instrument under which such property is received, this Certificate of Incorporation, the Bylaws of the corporation, or any laws applicable thereto.
