ARTICLE I NAME

The name of the corporation shall be: Key West Writers Guild, Inc.

ARTICLE II PRINCIPLE OFFICE

The principle office, place of business and mailing address of this corporation shall be: 1411 12th Street, Key West, FL 33040. (PO Box 4983, Key West, FL 33041)

ARTICLE III PURPOSE

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this corporation is to educate and promote literary excellence. Its goal is to provide opportunity for critiquing writers' work, to procure information about finding an agent, to gain information about marketing of writing and about the current publishing industry in general.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

ARTICLE IV MANNER OF ELECTIONS

The Board of Directors shall consist of the officers of this corporation – a President, Vice President, Treasurer, Secretary, all elected for a term of two (2) years. Method of election of directors is as stated in the bylaws.
