## Articles of Incorporation Pleasant Grove Baptist Church TALLAHASSEE, FLORIDA of Taylor County, Florida, Inc.

01 SEP 20 AM 11: 05 SECRETARY OF STATE

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

#### Article I - Name

The name of the corporation shall be: Pleasant Grove Baptist Church of Taylor County, Florida, Inc.

## Article II - Principal Place of Business & Mailing Address

The principal place of street address of this corporation shall be 8985 Alton Wentworth Road, Shady Grove, Florida 32357. The mailing address of this corporation shall be P.O. Box 682 Shady Grove, Florida 32357.

#### Article III - Purposes

The purposes for which the corporation is organized are exclusively religious, charitable, and educational within the meaning of section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(C)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal ax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

### **Article IV - Manner of Appointment of Directors**

The corporation refers to its directors as trustees. The manner in which the trustees are appointed shall be set forth in the constitution or bylaws. The initial trustees are:
