Article I

The name of the corporation is: T.H.E. Full Cornerstone Gospel Church Inc.


Article III

- A. This corporation is a Not-For-Profit corporation organized under chapter (47) Florida, Florida status, it is not organized for the private gain of any person.
1. To provide a daily place of worship & service; spiritual guidance and counseling, marriage, weddings, funeral arrangements, for those individuals in the Gainesville and surrounding communities.
  2. To provide outreach services to those in need, shelter and care to underprivileged and at risk low income youth in the Gainesville community target area. To provide food, clothing, transitional housing for the homeless, and special programs for the literacy, and slow learners and readers.
  3. To develop a support program addressing juvenile delinquency, crime prevention awareness, mentoring, drug abuse, and recovery.
  4. To provide additional support programs for foster children, child care, day care and senior adult care.
  5. To exercise all rights and powers conferred by the laws of the State of Florida upon Non-Profit Corporations.
- B Notwithstanding any other provisions of the Articles, the purpose for which the corporation is organized is exclusively religious, charitable, scientific, literacy, and educational within the meaning of section 501c3 of the Internal Revenue Code of the 1986 or the corresponding provision of any future U.S. Revenue Law.
- C. Provided however that the corporation shall not engage in any action which is not permitted to be carried on by Non-Profit Corporations under the Internal Revenue Code and no part of the net earnings of the corporation shall inure to the benefit of or be empowered to pay reasonable compensation to those people for services

rendered and to make payments and distribution in furtherance of its stated purpose.

#### Article IV

The corporation shall have voting members who shall be elected (and may be removed) by the voting members who shall have all the right and privileges of the Members of the Corporation. The By-Laws may provide for non-voting members of one or more classes, who shall be admitted in such manner and shall have such rights and privileges as are set forth in the By-Laws, but who shall not have the right to vote. DIRECTORS ARE ELECTED IN ACCORDANCE WITH THE BY-LAWS. Having been named as Registered Agent and to accept the service of process for the above stated corporation at the place designated in this certificate I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provision of all statutes relating to the proper and complete performance of my duties and I am familiar with and accept the obligations of my position as Registered Agent.
