**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF**

**SUNSHINE STATE FELLOWSHIP OF REGULAR BAPTIST CHURCHES, INC.**

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

**FIRST:** The name of the corporation is SUNSHINE STATE FELLOWSHIP OF REGULAR BAPTIST CHURCHES, INC.

**SECOND:** Text of each of the amendments is as follows:

a. The name "SUNSHINE STATE FELLOWSHIP OF REGULAR BAPTIST CHURCHES, INC." is deleted wherever it appears in the Articles of Incorporation and substituted in lieu thereof is the name "SUNSHINE BAPTIST FELLOWSHIP, INC.."


b. The first full paragraph of "Article III: Purpose" is deleted therefrom and substituted in lieu thereof is the following:

"To glorify God by providing an arena for Baptist churches and organizations to participate interdependently in the common cause of advancing biblically authentic, dynamic, compassionate Christianity to all people groups."

**THIRD:** The amendment was adopted on November 23, 2003.

**FOURTH:** The amendment was adopted by the members and directors.

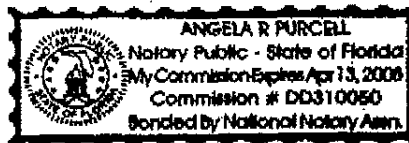
