## Exhibit "A"

Article IX, Section 1 of the Articles of Incorporation shall be amended to read as follows:

"Section 1. Amendments. Amendments to these Articles of Incorporation shall be proposed and approved by the Board of Directors and thereafter submitted to a meeting of the membership of the Association for adoption or rejection (by affirmative vote of 66-2/3% of the Members), all in the manner provided, and in accordance with the notice provisions of, Section 617.017, Florida Statutes.

These Articles of Incorporation shall be amended by approval of sixty percent (60%) of the total voting interests of the Owners, such Owners either:

- (a) voting in person or by proxy at any annual members meeting or special members meeting, or
- (b) submitting written agreements adopting the amendment(s) without a members meeting.

In addition approval of the Board of Directors shall be required for amendment of these Articles of Incorporation."
