We, the undersigned, who are citizens of the United States, for the purpose of forming a body corporate not for profit under the laws of the State of Florida, do hereby certify, make, subscribe, acknowledge and file in the office of the Secretary of State of Florida, this certificate of incorporation.

ARTICLE I:

The name of the corporation shall be *HEART OF GOD MINISTRIES International*, *Inc.*, and it shall be a non-profit corporation under the laws of the State of Florida.

ARTICLE II:

The principal office and place of business of the corporation shall be 6100-B Fairfield Drive, Pensacola Florida 32506.

ARTICLE III:

Said corporation is organized exclusively for religious and charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the internal Revenue Code, or the corresponding section of any future federal tax code. Said corporation shall conduct the affairs of an Independent Christian Church Organization. Said corporation shall own, manage, control, use, convey and otherwise deal in real and personal property of every nature and kind for the purpose of conducting the affairs of the church organization. The corporation shall use said properties for the activities of promoting the Doctrines of Faith of the Holy Bible in the furtherance of the Kingdom of God through the Knowledge and Saving Grace of Jesus Christ.

ARTICLE IV:

This corporation shall be established with the provision that the method of election of the Directors be stated in the Bylaws.

The Articles of Incorporation may be amended by the Director Board at any qualified meeting of the said corporation upon notice as provided in the Bylaws.

The number of Directors may be increased or diminished from time to time by the provisions of the Bylaws. The names and addresses of the initial directors of the corporation are as follows:

ARTICLE V:

The corporation shall have the general powers of a Florida corporation not for profit, including each of those general powers enumerated under Florida statute 607.011 chapter 617 and chapter 91-208, laws of Florida.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in ARTICLE III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VI:

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VII:
