ARTICLES of AMENDMENT to ARTICLES of INCORPORATION

ARTICLE ONE: Name

The name of the Corporation is

Heart of God Ministries International, Inc.

organized pursuant to the Florida, Not for Profit Corporation Code. No one may have it's name or same name. Document N01000007895

ARTICLE TWO: Principle Office

The registered office of the corporation is

ARTICLE THREE: Purpose

The Corporation is organized under GOD in Which We Trust in accordance to the 1st Amendment of the United States Constitution and GOD Divine Status (1 Corinthians 12:28). This corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. This Religious Benefit Corporation is part of the New Testament Church, which is the body of our Lord and Savior Jesus Christ to promote religious activities. This Corporation is a person authorized to transact business. It can borrow, sue, file bankruptcy and more.

The corporation is tax exempt and can receive tax-deductible contributions as outlined in IRS Publication 557 and Application 1023 is established as a 501(c)(3) entity and as such the corporation is not required to file annually, tax returns for church or religious related business.

The corporation shall establish and carry out business related to, but, not limited to: The Constitution and Preamble; Statements of Faith; Bylaws; Operational Procedures; Divine and other related religious activities.

The corporation is organized and operated exclusively for Religious, Educational and Charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Not withstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on by a corporation exempt from federal income tax under Section 501(c)(3) regulations.

The property of this corporation is irrevocably dedicated to Religious, Educational and Charitable purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

This corporation is organized exclusively for religious, educational and charitable purposes, including for such purpose, the making of distributions to organizations that qualify as exempt under section 501(c)(30). Said corporation shall own, manage, control, use, convey and otherwise deal in real and personal property for the purpose of conducting its affairs.

ARTICLE FOUR: Manner of Election

The number of Directors shall be three (3) wherein the number of Directors may be increased by provision in Bylaw: Article 7, Section 2.

Any such assets not so disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE TEN: General Powers

ARTICLE ELEVEN: Asset Distributions

No part of the earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation is authorized and empowered to pay compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof.

ARTICLE TWELVE: Restricted Activities

No substantial part of activities of the corporation shall be the to propagate or otherwise attempt to influence legislation. The corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.
