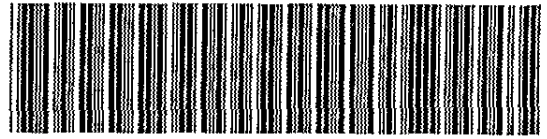



FIRST AMENDMENT TO
ARTICLES OF INCORPORATION
OF
CHIEFLAND MINISTERIAL ASSOCIATION, INC.
(a corporation not for profit)

Article Three of the Articles of Incorporation are hereby amended to read as follows:

GENERAL PURPOSE

The corporation is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. These general purposes and objects shall include cooperation with and helping to coordinate activities of various churches in and around the city of Chiefland, Florida and promote such churches, schools and other institutions connected therewith of a religious, educational or charitable character; to advance spiritual growth and enlightenment, moral and personal purity among its membership and the peoples of the community in which it is located; and to assist in the spread of the gospel of Jesus Christ to the ends of the earth.

The above amendment was adopted this 18th day of March, 2003, at a regular meeting of the membership of the corporation after proper notice had been given by written notice to each member church at least 10 days prior to the meeting. The procedure is consistent with Article Fourteen of the Articles of Incorporation and accordingly, this amendment shall be forwarded to and filed with the Florida Secretary of State.
