

## ARTICLES ÖF AMENDMENT TO ARTICLES OF INCORPORATION OF

PARKVIEW TOWNHOMES CONDOMINIUM ASSOCIATION, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida for profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The Articles of Incorporation of Parkview Townhomes Condominium Association, Inc., a Florida corporation, filed in Tallahassee on November 16, 2001, be and they hereby are amended in the following particulars:

Article IV(a) shall be amended to read as follows:

Perform all of the duties and obligations of the association as set forth in a certain Declaration of Condominium (the "Declaration") applicable to the tract of real property and to be recorded in the public records of Miami-Dade County, Florida.

Article IV(e) shall be amended to read as follows:

Participate in mergers, consolidations, or annex additional residential property, with other nonprofit condominium corporations organized for the same purposes, provided that any merger, consolidation, or annexation must have the consent by vote or written instrument of two thirds of the Members.

Article VII shall be amended to read as follows:

The owner or owners of each unit will be entitled to one vote for each unit owned. When more than one person holds an interest in any unit, all of those persons will be Members. The vote for such unit will be exercised as such Members determine among themselves, but in no event will more than one vote be cast with respect to any unit owned.

SECOND: The foregoing Amendments were approved by the Board of Directors. The number of votes cast for the Amendment were sufficient for approval. There no members on members entitle to vote on the amendment.

THIRD: The date of adoption of each Amendment: March 7, 2002.
