There are many ways of helping teenagers deal with certain mental illness crises in his/her life. One way that can be helpful is to make available resources that would offer positive insight in the time of a crisis. This will create sense confidentiality and a sense respect that someone is concerned about adverse situation and feelings. It can also foster positive self-esteem that can improve his or her motivation to want to succeed and not give up when things are looking impossible. At **Christian Brothers United Incorporations** several services will be render either on sites in the person home or at a center which is located in the community.

Religion

Religion is a mental health technique that is helpful. Religion may be a link to a person background that is looking for that personal, family relationship with the church relationship church. At **CBUI** we will rendered these services in the community as well as individual counseling at a home base community center or in the home.

The **CBUI** will also provided mental health counseling, individual counseling and spiritual guidance to juveniles that are incarcerated and to at risk juveniles in the community. This will provide hope and encouragement to the juvenile that it is not too late to change their delinquent behavior and to channel their energy to a more positive outlet in life. This will help filtrate their self-esteem and encourage a positive well being.

Individual and Group Counseling to Educate and Motivate

At **CBUI** we will also render services to Boot Camps, juvenile youth facilities and detention centers across America to correct at risk behavior with juveniles in the community. These type of services will prepare juveniles to overcome crisis in their life, to build self-esteem and readiest for better decision making. The juvenile boot camps, juvenile youth facilities and juvenile detention centers will serve as a deterrent to prevent recidivism and address mental health issues to increase productivity. Services will consist of providing individual counseling and group counseling inside of the facility to help at risk juveniles process their negative decision making and how they would handle the same situation if arises again. **CBUI** will be able to increase their knowledge about the community positive resources that would help them to avoid negative situations in the future.

The youth facility, juvenile detention center and the boot camp would provide a series of professional motivational classes to help build self-esteem and a positive outlook on educational. All levels of education would be offer to the juvenile while attained in the center, or facility. They would receive the same education as his/her regular school. Once finishing his/her education or time at the center or facility, the juvenile would either return to his/her community and complete school or receive his/her diploma from the facility or center.

Individual and Group Counseling to promote Education and Family Values

The CBUI will provide wrap around services to the school system to enhance and promote education through better decision making through home base and community contacts. It would also include parenting classes for teens and adults, abstinence and safe sex. The CBUI will provide mental health counseling, family counseling, one on one counseling and group counseling to at risk juveniles to address various issues within the school or the classroom setting.

Alcohol and Drug Rehabilitation

The CBUI would also render services to all teens with alcohol and drug abuse addiction to deter them from using the drug or lessen the habit of using the drug until the desire is alleviated. The teens would go through a process of being educated about the danger of drugs and how it can effect the body upon usage. They would receive mental health counseling to address their issue of desiring drug and alcohol as a mean to solve many problems, to be accepted among peers or any other mental health breakdown. A test would be given to measure the knowledge of each teen that will go through this process to ensure that resources can be found, and how to avoid these adversaries within the environment or community.

Job Skill Training, Job Placement and Independent Living Quarters

Provide shelter to teens that are living on the street. A teen shelter would be built to offer services such as job skills training, interviewing techniques, job placement, responding to your superior on the job, an independent living program to help teen to find a place to live within the community. The services would help teens with their first month rent and every other month when needed.
