The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, (Not For Profit) adopts the following Articles of Incorporation of such corporation:

ARTICLE I: Name

The name of the corporation shall be Glades Covenant Community Church, Inc.

ARTICLE II: Principal Office

The principal place of business of the corporation shall be 105 N.W. 1st Avenue South Bay, Florida 33493.

ARTICLE III: Purpose

The purpose for which the corporation is organized is to rebuild the walls of communities, both local and international. It's spiritual, social and economic walls, and to bring to bear upon our communities, through prayer, intercession, and renewed lives, the glory of God in our midst. 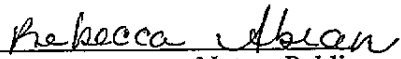
