The undersigned incorporator, for the purpose of forming a non-profit corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of this corporation shall be **She Center, Inc.**

ARTICLE II: COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the FLORIDA DEPARTMENT OF STATE. This corporation's duration shall be perpetual.

ARTICLE III: PURPOSES, POWERS, & RIGHTS

This corporation is being organized for the purpose of providing and promoting abstinence based sex education programs targeted to middle and high school students and for engaging in any lawful act or activity for which corporations may be organized under the laws of the State of Florida.
