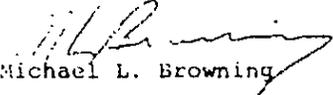

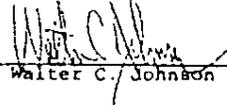

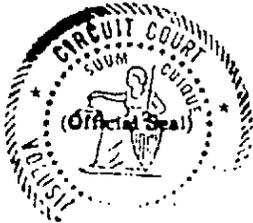

CHARTER

OF

THE KIWANIS CLUB OF NEW SMYRNA BEACH, INC.

The undersigned, all citizens of the United States and residents of Volusia County, State of Florida, desiring to form a Corporation not for profit, under the Statutes of the State of Florida in such cases made and provided, do hereby certify:

ARTICLE I

The name of the Corporation shall be "THE KIWANIS CLUB OF NEW SMYRNA BEACH, INC."; the location of the Corporation shall be New Smyrna Beach, Volusia County, Florida.

ARTICLE II

The objects for which incorporation is sought are:

1. To give primacy to the human and spiritual rather than to the material values of life.
2. To encourage the daily living of the Golden Rule in all human relationships.
3. To promote the adoption and the application of higher social, business, and professional standards.
4. To develop, by precept and example, a more intelligent, aggressive, and serviceable citizenship.
5. To provide through Kiwanis clubs, a practical means to form enduring friendships, to render altruistic service, and to build better communities.
6. To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, patriotism, and good will.
7. For the purposes aforesaid, to take over the assets, rights and franchises of the unincorporated club, known as the Kiwanis Club of New Smyrna Beach, and

8. To do all such things as are incidental or conducive to the attainment of the above objects.

ARTICLE III

The membership of this Corporation shall at all times consist of persons as are members in good standing of the Club, as shown by the records of said club; in one or more of the following classifications, as defined by the Standard Form of Club By-Laws adopted by Kewanee International December 6, 1934, as amended to and including October 26, 1952, to which reference is hereby made and the terms of which are incorporated herein, viz., Active, Reserve, Privileged, and Honorary.

ARTICLE IV.

The incorporators propose that this Corporation shall have perpetual existence and from time to time, in the event the law requires, this Charter shall be renewed to accomplish this purpose.

The Board of Directors shall determine the policies and activities of the club, elect and discipline members, approve the budget, approve all bills, take counsel with committees, and have general management of the club.

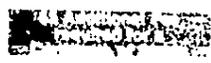

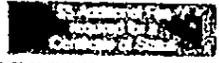
