ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized is to provide the means by which musicians may rehearse and perform choral music.

ARTICLE IV MANNER OF ELECTION

- A. Officers of the Corporation shall be a President, Vice-President, Secretary, Treasurer and any other officers the Corporation shall deem necessary.
- B. The Music Director shall be a permanent, voting officer of the Corporation.
- C. Officers of the Corporation shall be elected by the current members of the Indialantic Chamber Singers, Inc.
- D. Elections shall be held at a meeting of the Corporation specifically called for this purpose and announced in writing at least two (2) weeks in advance of the elections.

- G. Vacancies may be filled by called elections for this purpose.
