1. The name of the corporation is DEBARY PLANTATION UNIT 21B HOMEOWNERS ASSOCIATION, INC.

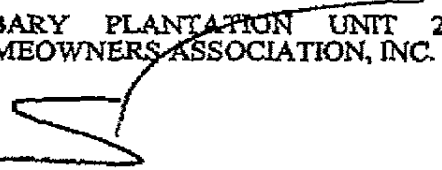
2. The date of filing the Articles of Incorporation was January 18, 2002.
