a Florida not for profit corporation**

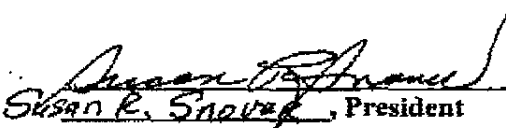
